## **Graduates' Tracking with Administrative Data in Poland**

Different aspects of the Polish Graduate Tracking System will be presented. This register-based system provides reliable information on Polish higher education graduates' labour market performance in form of automatic reports and interactive infographics. The tracking system covers every study programme on every Higher Education Institution in Poland. The talk starts with a brief introduction to the higher education system in Poland. Then the data sources of the system and the mechanisms of privacy protection are explained. Next the indicators used in the system, including relative indicators of unemployment and wages are presented. These indicators allow a fair comparison of labour market performance of graduates living in regions with different economic situation and are also useful tools for international comparisons. Finally, examples of reports and infographics, interesting results and some more in-depth analyses based on the data from the Polish Graduate Tracking System are given.

He is the founder and the head of the Education Quality Evaluation Unit at the University of Warsaw. He is also the head of the expert team that created the Polish Graduate Tracking System and develops it further. His research interests include social choice theory, statistics, social research methodology, register-based analysis, evaluation, educational research, and graduates' labor market performance.

Agnieszka Chłoń-Domińczak (Ph.D.) is an associate professor at Warsaw School of Economics and Educational Research Institute in Warsaw. She is a member of an expert team developing the Polish Graduate Tracking System. In 2008-2009 she was a Deputy Minister of Labour and Social Policy. Previously she headed the Department of Economic Analyses and Forecasting in the same Ministry. In 2007-2009 she was the vice president of Social Protection Committee of the European Council and until mid-2009 member Employment, Labour and Social Policy Committee of the OECD, she also chaired the Working Party on Social Policy of that Committee. Her research interest include: demography, pension systems, labour markets, social policy, health and education.

Marek Bożykowski is a doctoral candidate at the Institute of Sociology (Chair of Statistics, Demography and Mathematical Sociology) and a researcher at the Education Quality Evaluation Unit at the University of Warsaw. He is also one of the creators of the Polish Graduate Tracking System and a member of an expert team developing the system. His academic interests include statistics, social choice theory, fair distribution, register-based analysis, educational research, and graduates' labor market performance.
